


High Speed Silicon PIN Photodiode

Description

BPV10NF is a high sensitive and wide bandwidth PIN photodiode in a standard T–1 3 4 plastic package. The black epoxy is an universal IR filter, spectrally matched to GaAs (λ =950nm) and GaAlAs (λ =870nm) IR emitters. BPV10NF is optimized for serial infrared links according to the IrDA standard.

Applications

Infrared high speed remote control and free air transmission systems with high modulation frequencies or high data transmission rate requirements , especially for direct point to point links. BPV10NF is ideal for the design of transmission systems according to IrDA requirements and for carrier frequency based systems (e.g. ASK / FSK– coded, 450 kHz or 1.3 MHz). Recommended emitter diodes are TSHF 5...–series or TSSF 4500.




Figure 1. Reverse Dark Current vs. Ambient Temperature




Figure 2. Relative Reverse Light Current vs.
Ambient Temperature








Figure 3. Reverse Light Current vs. Irradiance




Figure 4. Reverse Light Current vs. Reverse Voltage




Figure 5. Diode Capacitance vs. Reverse Voltage




Figure 6. Relative Spectral Sensitivity vs. Wavelength





Figure 7. Relative Radiant Sensitivity vs. Angular Displacement

Ozone Depleting Substances Policy Statement

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.
